2017 Annual Report

(For 12 months ending January 31, 2018)

The Chatfield EDA regularly meets the fourth Monday of each month at 4:00 PM at the Chatfield Center for the Arts.

During 2017, there were 10 regular meetings and no special meetings. This compares to 11 regular and 5 special meetings in 2016, and 7 regular and 6 special meetings in 2015.

The difference in meeting count between years is due to approvals required for the Chatfield Center for the Arts Phase I renovation project which did not align with the normal meeting schedule. No regular meeting is held in November because of the annual EDA Gala held on the Tuesday before Thanksgiving.

No meetings were cancelled due to a lack of quorum in 2017, 2016, or 2015.

Project Highlights:

Industrial Drive

- Encouraged city council to improve the roadway surface from gravel to bituminous, achieving a long standing city goal to complete the project.
- Awarded \$177,103 grant from the Greater Minnesota Public Infrastructure (BDPI) for roadway improvements in conjunction with an expansion at Tuohy Furniture.
- Received **\$300,000, 0% loan** from MiEnergy Cooperative, saving taxpayers approximately \$50,000 in interest savings.
- Created pricing structure and marketing strategy for the city-owned vacant lots so that they can be sold and developed.
- Successfully encouraged city council to rename Industrial Drive to "Enterprise Drive."

Chatfield Center for the Arts

- Completed Phase I renovations.
- Successfully closed out Phase I renovation grant contract with the State of Minnesota.
- Approved the 2017 programming plan for Chatfield Center for the Arts, Inc.
- Applied to the Minnesota Department of Management and Budget for \$7.985 million of 2018 bonding funds to complete Phase II renovations. Funds could be potentially appropriated by the Legislature in spring 2018.
- Coordinated with lobbyist for Phase II renovation funding, making several trips to the Capitol to discuss the renovation project with legislators.

 Potter Auditorium received a "Best of the Best" award from readers of the Fillmore County Journal.

Public Transportation

 Assisted SEMCAC Rolling Hills Transit to develop and implement a bussing service in Chatfield.

Community Marketing

- Created the 2017 community "visitor's guide" brochure which includes a map of points
 of interest, narrative about Chatfield fun facts and history, and community photos.
 Distributed the brochure to 100 tourism related locations in Minnesota, lowa, and
 Wisconsin.
- Created 3D concept renderings of both the Twiford Street and Industrial Drive properties owned by the city that are being marketed for development. Updated community marketing pieces to include these new images.
- Hosted approximately 65 developers, builders, realtors, architects and the like in June
 on the CEDA 2017 "Regional Development Tour" which gave participants a tour of the
 city, potential development sites, discussed past projects, and other community
 highlights. The tour led to the city receiving a \$300,000, 0% loan from MiEnergy
 Cooperative and several developer inquiries.
- Redesigned and recreated the content of the EDA section of the city website.
- Refreshed general community marketing pieces.
- Chose design for 2018 community "visitor's guide" brochure.

Downtown Façade Improvement Grant Program

• Completed and closed out the program. In total, the program assisted 7 downtown businesses with grants totaling \$28,338 for exterior improvements. Project investments totaled \$38,929.

Revolving Loan Fund:

- \$25,353 loan made to Sarah Iverson Corner Cuts Salon
- Managed past due and defaulted loans.

Hosted a visit from the Minnesota commissioners of Transportation, Natural Resources, Employment and Economic Development, and Agriculture.

Hosted Annual EDA Gala - November 2016

Approximately 65 attendees, including 2 state senators and 2 state representatives.

Regional Development Participation

- Renewed membership and participated in regional development initiatives including Rochester Area Economic Development, Inc. and Journey to Growth.
- Pledged to contribute to regional economic development indicator "dashboard" project, although the project did not move forward. No EDA funds were expended.

Other Required Reporting

- Completed annual Business Subsidy report to Minnesota DEED.
- Completed bi-annual reports on the economic development sales tax grant funds to the City of Rochester.

General Business Assistance

• Met with 48 individual current and/or prospective businesses in regards to projects, issues, programs, business planning, financial packaging and other general assistance.
